Tom M. was elected Treasurer and Rojo R. stepped up and took the previously vacant Intergroup Liaison position. There, at the time, wasn't anyone willing to stand for Web Chair, but subsequently a replacement for that position was found and is pending approval at the next Intergroup meeting. Unfortunately 2 positions on the steering committee were left unfilled: Special Needs Coordinator (develops and coordinates programs for carrying the message to alcoholics with special needs) and Media Librarian (maintains the media library, adds new material, etc.). Requirements for eligibility for Steering Committee membership: "Any member of Alcoholics Anonymous with previous or current experience with the Central Office having at least 2 years of continuous sobriety shall be eligible for office." (Central Office By-laws, Article V, Section 2). Being on the Steering Committee is a wonderful way to do service work, meet more members of the fellowship you normally wouldn't, get more involved in your (and other's) recovery, and it takes nowhere near as much time or effort as you might think (about 5 hours monthly once you're used to it - plus a monthly Steering Committee meeting and Intergroup Rep meeting). 29TH ANNUAL INTERGROUP/CENTRAL OFFICE AAWS/AAGV SEMINAR REPORT (continued from last month)

Friday night's sharing session was with AAWS, and principally about the increase of the literature prices and the reason behind it. Class B AAWS Board Chair Bill N. started the share by saying he was very aware of what CO does, and that we are the one who are called by people in need of AA. We (CO) are the one who stand on the firing line. So a little background of the AAWS budget: In 2001-2002, the reserve fund was full, and at times over-full, so AAWS decreased the cost of the new 4th Edition by \$1 from the cost of the 3rd Edition, and budgeted to lose \$600K. The annual pension cost of the AAWS and the Grapevine at that time was \$302,311, or 6% of the budget. From 2002-2006, the pension cost lose 100%, to \$702,107, or 17% of the budget. In 2006, the 'pension guarantee act of 2006', which targeted higher premiums for pension insurance andtargeted funding levels was proposed, and then passed in 2008. Lieberman Bros. announced their bankruptcy, and the recession began. 2009, 401K contributions declined. In 2012, the reserve fund was still ³/₄ full, pensions had risen to 31% of the budget, or \$1.8M. A feasibility study was made and it was decided that AAWS needed to play catch-up w/pension funding and change the retirement system. In 2013 new employees went into a defined contribution system. This was done to help protect the board 20 years from now. It was decided that, although the reserve was still full, the pension fund was now \$2.2M, and therefore it was voted to move \$1.5M from the reserve to provide more funding for the pensions, and to keep insurance premiums down. This actually resulted in saving AAWS and GV \$600-700K. All this was done to be in compliance with the 2006 act, and would lower cost to pension funds to \$1.6M, and would put the reserve at 8 mo. or less. The decision to raise literature prices was painful, but looking 3 years out, the need was there. The figures for e-book sales being sold by Amazon, Apple, and Barnes & Noble have been staggering over those sales made by the AAWS platform, and have made a difference in literature sales. Overall, it is found that people still want a 'hard copy' of the Big Book, even after the purchase of an e-book. GSO offices in foreign countries all have a license to print AAWS literature, and AAWS is now struggling with the decision to keep that practice in force, do to the world conflicts now happening. Removal of permission to print will have what affect on the future of AA world wide in carrying the message?

The Public Information Committee has a comprehensive media plan, and is currently wrestling with technology and how to preserve the message. The GSO office is undergoing renovation to bring AAWS and GV onto the same floor. This will show unity between the two, and it's critical that we support each other in the vital services that each provides. Greg T., GSO Publications Director – GSO is bringing several new publications to the literature front: 1) revised 'Circle of Love' pamphlet, 2) 'Markings On A Journey' video is now on DVD. (It has been a favorite in 3 languages since coming out in 2003), and the brand new pamphlet, 'Many Paths to Spirituality'. One of the busiest parts of the department is responding to requests for translations and licenses around the world. The BB is now available in 69 languages, including a translation into Navajo, which should be completed next year. AAWS now has 1379 total copyrights that this department oversees. A new catalog is being printed as we were in Chicago. The new web site is now 120 days old, and is still being tweaked. Any suggestions for improvement and how it does or does not work are appreciated. Andrea Brennan, Literature Order Director – her department consists of 3 other people besides herself, with 2 of them being bilingual. They process over 35,000 orders/year. Online sales account for 45% on income, not of amount of orders. That includes the intergroup only site. Andrea plans to retire next October, after starting at GSO in 1978.

Saturday was the Central Office staff meeting in the first part of the morning. This was a non-recorded meeting, and I won't report what was said. The next workshop was AA Phones – 12 step calls, chronic callers, The Judge said..., dealing with active drunks, suicide calls, and after hour/answering service phones. I found that most of what was shared is already implemented by this office, but I did hear several things of interest. One was sponsoring a night phone workshop for persons interested in taking the phones at night, and to give the night phone people a list of "important numbers" as a part of the package the office supplies. Also to have a night phone orientation every 6 months. In recruiting volunteers, make a help wanted poster. There was the suggestion that when forwarding to the night phone volunteer's personal phone, ask that person to take their personal message off the phone for the duration of their shift. Have an acknowledgement in office manual for volunteers that they may receive suicide calls, and to ask the caller if they had a plan for killing themselves. If so, call 911. Central Office encourages all groups to elect an Intergroup representative. Join us at the next Intergroup meeting the second Sunday of every month, at 2 pm, at the Brownbaggers.

Requirements: Six mos. of sobriety and a sponsor to serve as deskworker. There are five two hour shifts 8-10 a.m. M-F. The rest of the shifts are 3 hours long.
