Step 3: "Made a decision to turn our will Tradition 3: "The only requirement for and our lives over to the care of God as we understood him."

The Third Step Prayer: "God, I offer myself to Thee-to build with me and to do with me as Thou wilt. Relieve me of the bondage of self, that I may better do Thy Will. Take away my difficulties, that victory over them may bear witness to those I would help of Thy Power, Thy Love, and Thy Way of life. May I do Thy Will always." -Alcoholics Anonymous p63

This is the step that so frightened me in my early sobriety. For did this step not say that I would be spending the rest of my life playing trombone on the corner with the Salvation Army band? Did it not say that I was to give up all that I enjoyed? All that I thought fun? All that I was? In short, was I not to be sentenced to eternal dork-dom? Quite the contrary, it turns out. The truth is that all I had to give up was selfishness, fear, and the belief in limitation of any kind. Surrendering myself to God did not cause me to lose any enjoyment, in fact I have gained immeasurably in happiness, peace and serenity. For all that I was afraid to relinquish (mind you I was sleeping on a couch by the railroad tracks without a friend in the world) I have been compensated with a new light thrown upon every phase of my life in a wonderful new world.

A.A. membership is a desire to stop drinking."

This tradition is packed with meaning. For A.A. is really saying to every serious drinker, "You are an A.A. member if you say so. You can declare yourself in; nobody can keep you out." -Twelve Steps and Twelve Traditions p139

Why did A.A. finally drop all its membership regulations? Why did we leave it to each newcomer to decide himself whether he was an alcoholic and whether he should join us?...The answer, now seen in Tradition Three, was simplicity itself. At last experience taught us that to take away any alcoholic's full chance was sometimes to pronounce his death sentence, and often to condemn him to endless misery. Who dared to be judge, jury, and executioner of his own sick brother? -Twelve Steps and Twelve Traditions p141

When I finally made it into the rooms of A.A, I was welcomed with open arms by a room full of people 30+ years my senior. I was loved despite, or in some cases because of, our differences. I remember reading, on the wall of the old Downtown Group, "You are a member if you say your are." It was the first time I had ever been granted membership to anything. The loving, tolerant old-timers were patient with me while I learned the ways of our fellowship.

Concept 3: "As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

Every trusted servant every A.A. entity—at all levels of service—has the right "To decide...how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises." That is, they can "decide which problems they will dispose of themselves and upon which matters they will report, consult, or ask specific directions."

But this right also means the Fellowship mush have trust in its "trusted servants." If the groups instruct their G.S.R.s rather than giving them a "Right of Decision," then the area conference is hamstrung. If the G.S.R.s instruct the area delegates rather than giving them a "Right of Decision," then the General Service Conference is hamstrung. "Our entire A.A. program rests squarely upon the principle of mutual trust. We trust God, we trust A.A., and we trust each other." -The Twelve Concepts for World Service Illustrated

YOUTH ENJOYING SOBRIETY!

I attended my first AA meeting at 21 years old. Though I did not stay sober from then on, a seed was planted: hope. I had been drinking against my will for about four years by that point. I had been living in hell as far back as memory serves me – albeit a hell that provided an occasional figurative glass of ice water.

The seed of hope that was planted in me that day lay dormant for some time, but it was there. I somehow knew that there were people with the same affliction I had, but were somehow dealing with it and living a reasonably happy life.

That seed was planted in Florida. Subsequently, I paid inevitable consequences related to my alcoholism and its attendant behavior. I have spent most of the years between then and now either in jail or prison.

That granule of hope I carried in my heart did not keep me sober. What it did do was provide me with the knowledge of where to go when it got bad enough. And it had to get really bad to be "enough".

Thankfully, I was given an excruciating moment of clarity. I was once again in a jail cell. But this time I could not stand who I was or the life that I was living. I saw my life – past, present and future – and was defeated. Completely. This was the fertilizer that activated the seed that was planted so many years ago. As this seed grew, I knew where I could go for help. AA.

I walked out of prison on Feb. 25, 2008, arrived in Albuquerque by bus, and realized I did not know how to live. I knew how to numb myself; I knew how to commit crime (though I obviously neglected learning how to avoid being caught); I knew how to do time. I was scared and I was desperate.

I walked into the Desert Club and found the original hope that had been offered so long before. There, there were people who smiled and joked and had jobs and cars and did not have to drink. There I was offered a design for living that would solve all of my problems.

I went to 2-3 meetings a day. I got a Big Book and 12x12. I got a sponsor. I started working steps with willingness only the dying have. As I progressed into the steps, as I experienced day after day of living in the solution, something changed. I began to feel okay with who I was and what I was doing. My motivation to continue the program of Alcoholics Anonymous changed. I did not take the steps just to not die anymore, I did not incorporate the principles into my life just to quiet the insane

voices in my head anymore, I was given a psychic change and I like the results. I liked who I was and I began to find peace with the world around me. I no longer thought of drinking.

These gifts were all possible because some alcoholics were having a meeting many years ago and shared their hope with me. Thank God they did. Now that I am able, I carry the message as they did. I also gratefully serve on the 2010 NMCYPAA (New Mexico Conference of Young People in A.A.) host committee as a part of my sobriety.


