**Step 6: "Were entirely ready to have God remove all these defects of character."**

Having been granted a perfect release from alcoholism, why the shouldn't we be able to achieve by the same means a perfect release from every other difficulty or defect? *-Twelve Steps and Twelve Traditions p64* So Step Six...is A.A.'s way of stating the best possible attitude one can take in order to make a beginning on this lifetime job. This does not mean that we expect all our character defects to be lifted out of us as the drive to drink was. A few of them may be, but with most of them we shall have to be content with patient improvement. The key words "entirely ready" underline the fact that we want to aim at the very best we know or can learn. *-Twelve Steps and Twelve Traditions p65* For me, Step 6 is a living and learning process. The more I live with the grace, care and protection from God, the more I experience its accompanying peace and serenity, the more familiar it feels. Likewise, so do I find myself growing ever more uncomfortable when my character defects drive me away from reliance on God as I try and run the show myself. My becoming entirely ready is more an honest evaluation of shortfalls than anything. Truly a case of progress rather than perfection.

**Tradition 6: "An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose."**

These adventures implanted a deep-rooted conviction that in no circumstances could we endorse any related enterprise, no matter how good. We of Alcoholics Anonymous could not be all things to all men, nor should we try. *-Twelve Steps and Twelve Traditions p157* "Alcoholics Anonymous saved my life, and it comes first." *-Twelve Steps and Twelve Traditions p159* I learned to appreciate the wisdom of this tradition through my own personal experiences in the rooms of A.A., much of the learning coming through personal friendships. The simplest example would be that of lending money. How often have I lent money to a friend or newcomer, only to find myself upset later when I am not repaid? What then happens? I lose a friend or a service opportunity. I find myself in an argument about money, rather than in a friendship. When I place my focus on friendship, and don't involve "outside issues" (especially my opinions on the other person's behavior) I don't find myself in the middle of controversy or arguments. I get to practice "Live & let live" here.

**Concept 6: "On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous."**

Bill makes the point that although "our service objective is always a spiritual one," nevertheless our world service is a "large business operation." "Indeed," he says, "our whole service structure resembles that of a large corporation. The A.A. groups are the stockholders, the delegates represent them, like proxy-holders, at the annual meeting; the General Service Board Trustees are actually the directors of a 'holding company.' And this holding company (the General Service Board) actually owns and controls the two 'subsidiaries' (A.A.W.S. and the A.A. Grapevine) which carry on the...services. "This very real analogy makes it...clear that, like any other board of directors, our trustees must be given large powers if they are to manage the...affairs of Alcoholics Anonymous." *-The Twelve Concepts for World Service Illustrated*

## THE SPIRITUAL CORE.

I struggled with the white man's interpretation of a God, due in part to the forced assimilation of religion in my life in being adopted into a white family. My first few years of sobriety were listening to the voices in my head debate this, "God as you understand Him." I also remember that defining moment, after saying "God as I understand him," over and over in a meeting and at what point coming to the realization of whom my God was. I thought, if I had a God, that God would be an Indian. Next, my God would be a She. I needed to only reflect back on my experiences with the male role models in my life; my biological father, brother, perpetrator, first boyfriend, ex-husband, and first relationship with a guy in AA. They were all alcoholics, womanizers, and abusers. Finally, I asked what would this God do, and the answer was, to love me unconditionally and forgive me. Those were the basics I needed to open up my mind, heart, and ears to what the program of Alcoholics Anonymous had to offer.

Yet, I have come to find, throughout the years that my understanding has changed and evolved as I had grown in sobriety and have had new life experiences and heard the experience, strength, and hope of others. Still I continued to have struggles with the God concept that I kept hearing of in meetings. I had gotten caught up with my childhood interpretation of God based on other's perceptions and struggled in AA and thinking you were trying to make me believe in your God (religion). Though I knew it was a spiritual program, I had continued to compare and contrast my understanding to yours.

At 13 years sober my sponsor sent me back to my third step because she did not hear the presence of God in my life or message. As I was taken back to those early days of struggling with a God as I understood him and faced discord, she then sent me back to my second step. I came to realize that I may have had a God, but had not built a relationship with that God as I understood. Once again, I was redefining my conception of a God and knew that I still had not let go, completely.

This program is not a past tense, I have "worked" the steps kind of program; but a present tense of I am continuously working the program. It took actively working the steps with a sponsor for her to see where I was hung up and for her to be willing, with love, to send me back to learn steps one and two. This correlated with where I am in the stage of life today. I am no longer that single mother of a six-year-old that came to in AA. I am a mother of two and a grandmother to two granddaughters. This journey made me realize that these two steps of the program were the Spiritual Core and they have to follow me into all my steps.

I had gone back to traditional ways of the sweat lodge and when I prayed it was to the four directions. My prayers are to the Creator and to my ancestors. I had felt my conflict was with your God, but no, it was with the middle man who forced his belief on others. I came to realize that I had contempt prior to investigation when it came to your God, and all I needed to do was befriend your God or Jesus. It did not make me born again or a Christian; it just meant befriend your God. It was a moment of clarity and the building of a true relationship with the God of my understanding at 15 years sober.

## YOUTH ENJOYING SOBRIETY!

---

Fans beat aimlessly at the thick, smoke ridden air. Years of coffee mugs had left a pattern of rings on the tables and the floor was stained a light yellow. While certain people dispersed throughout the room read *The Steps and The Traditions*, I remember feeling convinced that AA was trying to sell me religion. People talked about the Big Book, and I thought they meant the bible. Regardless, I identified with many of the stories that I heard. People welcomed me with open arms, but I wasn't ready. I believed that I was sick with the disease of alcoholism, but I was afraid to admit that I needed help, and the idea of quitting was something that I couldn't face. I walked out of the meeting that night at 13 years old, and my habits didn't miss a beat.

A month after my 14th birthday, I woke up in the hospital after hitting a bottom worse than ever before and ingesting an entire bottle of Tylenol. I was hallucinating and a tall machine was pumping clear liquid into my liver. After a few days they sent me to a different ward, and miraculously I had survived. It was then that I was presented with the choice between continuing as I was and suffering an alcoholic death, or becoming willing to change. I wasn't sure at first. A week and a half later, I arrived at a rehabilitation center in California. At the center we went to AA meetings every night and I found a sponsor that was willing to work with me out of the center. Soon I began to acquire an understanding of Alcoholics Anonymous that I had missed with my previous visit. For a while I was sure that I was incapable of living sober, but it's been nearly a year since, and I haven't found it necessary to take a drink.

I honestly didn't believe that I could ever pull myself out of the hole that I had created. Alcoholics Anonymous and my Higher Power have, without question, saved my life. As I am barely 15, I have many years ahead of me to work on sobriety and to help other alcoholics. For this, I am grateful. Thank you AA.

## VERY SOBER OLD(er) PEOPLE!

---

I was raised in a community in the middle of the Bible-Belt that could be called “redneck,” where morality is shouted from the rooftops. My great uncle, I'll call him Sam, was the town drunk in this small burg. My siblings and I were never told in so many words that he was no good, but the message came through.

On holidays someone would go to town and bring uncle Sam to the family dinner. When he would go out behind the granary to relieve himself (having already had a few beers) there would be subtle chuckles from the self righteous relatives.

Uncle Sam died when I was overseas in the armed forces. One of my aunts, who had never been a fan of uncle Sam, wrote a letter to all the relatives telling them the things we had never known about him. He had been the number one fan of the high school basketball team, and was even allowed to ride the bus taking the players (boys and girls) and cheerleaders to the out of town games.

I was shocked to learn that a moral degenerate was allowed to ride the bus with young boys and girls. This letter made me pretty angry (as I was by then a genuine alcoholic) because I never knew that this narrow minded community would find something good in the heart of my so-called degenerate of an uncle.

This helped me finally get it through my mind that alcoholism is not a disease that automatically makes me a moral degenerate, though it can, of course, contribute to that end.

I remember a Father Martin movie I saw in treatment. It was about attitudes. If I judge a new member, or someone coming back, even a homeless person on the street, I am destroying my own serenity. I don't know what my relatives hoped to gain by giving us young ones the impression that uncle Sam was no good. I do know that the program of Alcoholics Anonymous can help me to rise above the finger pointing and blame game.
