How should a sponsor be chosen?

The process of matching a newcomer and sponsor is as informal as everything else in A.A. Often, the new person simply approaches a more experienced member who seems compatible, and asks that member to be a sponsor. Most A.A.'s are happy and grateful to receive such a request.

An old A.A. saying suggests, "Stick with the winners." It's only reasonable to seek a sharing of experience with a member who seems to be using the A.A. program successfully in everyday life. There are no specific rules, but a good sponsor probably should be a year or more away from the last drink--and should seem to be *enjoying* sobriety.

A Fly in the Ointment

An atheist comes to terms with the Steps - Grapevine Dec. 2005

I have read many pieces in the Grapevine from agnostics, but not many from bona fide atheists. As an atheist, I have found over fifteen years of rewarding growth in A.A., but the absence of agreement on religious issues has been a challenge in relating with some members in the Fellowship.

Once I started to take A.A.'s suggestions, confusion gave way to clarity and A.A.'s gifts of happiness, serenity, and gratitude (the big three) slowly made their way into my life.

But there was a fly in the ointment for me back in those early days. At meeting after meeting, I heard that I would have to turn my back on the evidence of my own eyes if I expected lasting sobriety: that I'd have to somehow "come to believe" that a supernatural force was in charge of my life, that I'd have to "turn my will" over to this supernatural force, and even seek to discover "his will for me." I was horrified to think that such a denial of reality would be the price of sobriety for me.

I found it ironic that just as the cloud of insanity was finally lifting from my life, and just as I was getting my own mind back after years of alcoholic insanity, A.A. was now telling me that I'd have to do with my mind in sobriety exactly what alcohol forced me to do with my mind while I was drunk--abdicate its use. I would have to renounce my rational convictions. The idea that a God controls the universe still holds remarkable sway in today's A.A. community. I was in

despair, as alcoholics told me that if I couldn't learn to give up my grasp of reality and embrace a belief in the supernatural, my sobriety would be short-lived.

Then I found a sponsor, and he showed me the ropes. He guided me through my First Step inventory and taught me that sobriety was even possible for an alcoholic who was unable to pretend that reality was something is wasn't. In fact, he told me, honesty required *not pretending* about anything; and honesty, he told me, was a non-negotiable requirement for sobriety.

But to be honest, I would have to examine myself carefully; I would have to embrace a power that would let me see myself for what I was. After two decades drunk, I would have to make cognitive contact with the world again; I would have to turn my life over to the power of reason if I were to be "restored to sanity." After all, the essence of my alcoholic insanity was a cognitive break with reality. And the last thing I needed now was a brand-new break with reality -pretending to believe in the supernatural.

When I "turned my life over" to the higher power of reason, the insanity began to dissolve away. As it say on page 48 of our Big Book, "It finally beat us into a state of reasonableness."

Drawn to reason and away from mysticism, I discovered that life can be driven by the principles of the Steps rather than by my impulses and urges. As I "turned my life over" to the principles of the Steps, my former alcoholic behaviors began to take a back seat.

My character defects and shortcomings were all tied with urges and whims axis of my former alcoholic life. The more I aligned my life with the principles of the Steps, the more clearly I was able to see the world, and less frequently I found myself at the mercy of urges and impulses, guilt from harm done to others, or just plain fears. I was being set free.

It could never happened drunk; it could never have happened without discovering the principles of the Steps; it could never have happened with a mind paralyzed by superstitious belief in the supernatural. It happened when the principles of the Steps were put in to practice by a mind set free by the higher power of reason. It is a blessing for which I shall be forever grateful.

REDISTRICTING UPDATE

At our June District Meeting, the Ad Hoc Redistricting Committee made a recommendation that District 11 split into two districts. Groups residing north of Alameda to include Corrales, Bernalillo, Cochiti, San Felipe, Santo Domingo, Zia, Jemez Pueblo, Jemez Springs and Cuba along with Rio Rancho would become District 18. Groups presently residing in Albuquerque would remain as District 11. This will only come about if two-thirds of the Groups attending the District Meeting on July 14, 2007 agree in favor of splitting the District. Less than a two-thirds vote for redistricting would result in an unfavorable support of redistricting and the motion will fail. Only group representatives (GSRs) or alternate representatives will be eligible to vote for their group. Each group has one vote that will be cast by the GSR or Alternate GSR. District Meetings are open to all, and we encourage those interested to attend.
