**Step 8** "Made a list of all persons we had harmed, and became willing to make amends to them all."

**Tradition 8** (*Short Form*) "Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers."

(*Long Form*) "Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. twelfth step work is never to be paid for."

**Concept 8** (*Short Form*) "The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active Services, exercising this through their ability to elect all the directors of these entities." (*Long Form*) "The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of overall policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities."

### Whose Responsibility?

"An A.A. group, as such, cannot take on all the personal problems of its members, let alone those of non-alcoholics in the world around us. The A.A. group is not, for example, a mediator of domestic relations, nor does it furnish personal financial aid to anyone.

"Though a member may sometimes be helped in such matters by his friends in A.A., the primary responsibility for the solutions of all his problems of living and growing rests squarely upon the individual himself. Should an A.A. group attempt this sort of help, its effectiveness and energies would be hopelessly dissipated.

"This is why -- freedom from alcohol – through the teaching and practice of A.A.'s Twelve Steps, is the sole purpose of the group. If we don't stick to this cardinal principle, we shall almost certainly collapse. And if we collapse we cannot help anyone,"

(Bill W. in a letter written in 1966, over 31 years after his last drink.)

"I am responsible . . . When anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there. And for that: I am responsible."

### FROM THE EDITOR'S DESK

PIO is suffering growing pains of a sort - the AA events calendar (page 6) has almost outgrown the allotted space (no worries, the space will grow to accomodate all pertinent events). The sobriety birthday list (page 5) is receiving more submissions (c'mon, groups, if you don't sent me a list I can't include you - let PIO help fellowship members celebrate milestones in sobriety). Last month's Intergroup Rep (marathon?) Meeting Minutes (pages 4, 5 and 7) marks the first time since I've been at PIO that the minutes have taken up more than 2 pages!

Article submissions have dwindled to *none*...it seems that apathy reigns as far as writing is concerned...let's hope (pray) it's not reigning in individual sobriety and recovery! Even the specific appeal for articles on Central Office and being a CO desk worker have produced no results (or inquiries, for that matter). Well... back to GV reprints and such, what a pity.

This month PIO is publishing twice the number of copies as normal in an effort to raise awareness of Central Office, what it does and the importance of participating in Intergroup. Intergroup represents...and Central Office serves... 5 Districts (3,11,12,13 & 18) in Area 46. These districts are home to over 192 AA groups that have over 400 meetings weekly. Wow - I just did the numbers and yes, it took a while... Here's the sad part: only 75 of these groups have contributed to Central Office so far this year (this is where the vast majority of our funding comes from) and only about 25 of these groups are regularly represented at the Intergroup Rep meeting. C'mon, people! I'll be visiting and bringing around copies of PIO to some of your groups this month, especially ones that don't participate in Intergroup - and hopefully I'll find some cool groups I've never been to before, meet some more cool (sober) friends and run into some people I haven't seen in a while :) If you'd like me to come to your group with some copies, please let me know.

Intergroup is, among other things, a forum to facilitate networking, coordinating, communicating and cooperation among Albuquerque area AA groups in order to facilitate our primary purpose - to carry the message to the still suffering alcoholic. Intergroup also serves as the "group conscience" for Central Office. Only 25 of 192 groups are represented at Intergroup... I have been taught that isolating is bad for my sobriety - might it not be a dangerous thing for groups as well? Intergroup Reps meet once a month at 2pm on the 1st Sunday of the month at Brownbaggers - it's not a major committment to attend, and it can make such a positive difference if you do.

Central Office (CO) serves many vital functions for AA in the Albuquerque area, some of which I'll explain here. We operate a 24/7/365 AA hotline which is often the first point of contact for the still suffering alcoholic. CO is responsible for the website (albuquerqueaa.org) with it's interactive meeting schedule, event calendar and many other interesting & useful features. CO publishes this newsletter and the printed schedules so many rely on. CO is open 7 days a week and offers very reasonably priced AA books, literature and sobriety medallions/coins. CO has a free media library that you can check media (speaker CDs, etc.) out from with a small deposit.

These are just some of the functions of Intergroup and Central Office provide to the fellowship in this area...vital functions that only survive through the work of numerous volunteers and voluntary contributions from individuals and groups in the Albuquerque Area. Look for more in upcoming issues about Central Office & Intergroup. And we'd love to see you at our next Intergroup Rep meeting!

Singleness of Purpose From Box 459, published bimonthly the General Service Office of Alcoholics Anonymous, Februaru/March 2003 by George E. Valiant, M. D. Class A (nonalcoholic) trustee A.A. General Service Board

"Singleness of purpose" is essential to the effective treatment of alcoholism. The reason for such exaggerated focus is to overcome denial. The denial associated with alcoholism is cunning, baffling, and powerful and affects the patient, helper, and the community. Unless alcoholism is kept relentlessly in the foreground, other issues will usurp everybody's attention.

Mental health workers, however, have great difficulty with A.A.'s Fifth Tradition: "Each group has but one primary purposeto carry its message to the alcoholic who still suffers." Since mental health workers often admire the success and geographic availability of Alcoholics Anonymous, they understandably wish to broaden its membership to include other substance abusers. They also note that pure alcohol abuse is becoming less frequent, and polydrug abuse more common. In addition, mental health workers sometimes view singleness of purpose as outmoded and exclusionary. They worry that the Tradition is a holdover from the early days of A.A. and that the young, the poor and the minority with a criminal record will be barred. Besides, when there is no professional drug treatment center or Narcotics Anonymous (NA) group easily available, mental health workers find it hard to understand why A.A., with its tradition of Twelfth Step work, won't step in and fill the breach.

As both a mental health worker and a researcher, it seems to me that there are two arguments that trump these concerns. First, the Third Tradition of A.A., "The only requirement for A.A. membership is a desire to stop drinking," renders A.A. nonexclusionary. Each year A.A. welcomes many thousands of minorities, many thousands of poor, many thousands of alcoholics with coexistent drug problems and tens of thousands of convicts into its membership. Nobody with a desire to stop drinking is excluded.

The second argument, that "Singleness of Purpose" is necessary to overcome denial, is even more compelling. Given a choice, nobody wants to talk about alcoholism. In contrast, drug addiction commands newspaper headlines, research funding and the attention of clinical audiences. After two years of work at the Lexington, Kentucky Federal Narcotics Treatment Center, I, a mere assistant professor, was invited around the world to lecture on heroin addiction. In the late 1990s, as a full professor and after 25 years of research on alcoholism and its enormous morbidity, I was finally asked to give a medical grand rounds on alcohol in my home city. My assigned topic, "Why alcohol is good for your health." In short, the greatest single obstacle to the proper treatment of alcoholism is denial.

I first began my psychiatric career at a deeply dedicated community health center. The community had voted alcohol abuse as their biggest problem. After its first ten years of operation the center was still confming itself to addressing the community's most pressing second, third, and fourth problems. No resources at all were devoted to alcohol treatment.

I moved to another community mental health center that had listened to its citizens and had opened an alcohol treatment center. In being asked to fill the position of co-director of the clinic I was the last staff psychiatrist hired by the mental health center. Significantly, I had had no experience with alcoholism, but no one else wanted the job.

Put differently, the experimentally documented success of A.A. in the treatment of alcoholism is in part because A.A. groups are the only place in the world where the focus is on alcoholism and nothing but alcoholism. There is simply no other way to overcome the denial.

Take Back to groups: Going to fill Alternate coordinator position: Prior experience with central office is highly desired. Have 2 applications already.

#### Alternate Central Office Coordinator (Position currently vacant)

Member at Large Looking at budget questions. Do we need to hire a new alt. coordinator? I am looking at bylaws from around the country. Steering committee is exchanging ideas via e-mail. No decisions made, but looking and discussing all of this is taking place. This is where we are now. Q. So will this be solved by the end of the month? You are asking groups to put in résumés but talking about not filling the position.A. Peggy: I don't know how to answer that. Q. Has there been discussion about weather or not you will hire one, and if so what changes will you make? A. Yes, we have been going over all of these issues, but steering committee did not vote to give us time to go over this, however if Michael feels the need to hire one, he has the right to do that. But the person he wants to hire will need the approval of the steering and rep committee. Michael- It is good to act inline with the bylaws, which is what I am doing. The groups may have something to say about the service structure getting hijacked and overtaken. Peggy- We can change this language in the bylaws today; we are not curtailing services, this is what I want to take a look at. Steering committee is taking place before someone gets hired. But we offer more office hours and work more than other central offices. The biggest groups have at least one full time employee and some have a part time one too. I will look at other offices.This is not a question about how we can make Michael work more, but if we can change the work so he doesn't have to work more in order to run the office if we don't have the money to do it.- Don: It is not correct to state that in order to stay inline with the bylaws as Michael said that he has to hire a new person. It says "if necessary" and maybe it isn't. But it's his job to run the office which is important, and this is the way he sees best. We need to balance the needs of the fellowship with the needs of central office. The issue is money, is it irresponsible to continue running the office if we don't have the money to do it.Ally - So the question is what's good for AA, and what's good for Central office? What kinds of thing does the coordinator need if he can't do it by himself, and can those things be filled by volunteers? I trust the steering committee is taking action and will find a solution.Michael- Q. I remember talking about how to increase revenues? With the new circumstances are we still concerned with that? Michael's job is to collect résumés- we are in charge of how it's organized.Don- Michael is in charge of everything- the steering committee isn't involved in any of it. But we have some financial shortfalls in the future if we keep going this way, but Michael doesn't think so which is why he wants to hire a new person. Jeremy- lets continue with reports, and have this discussion in old business.

OLD BUSINESS Skitch may not be here since he is on-call.Steve- Motion: Next month issue we double production run in order to reach uninvolved groups.2nd by Allen. Q. How many do we normally do? A. 330. And Steve distributes them. Do you really need 300 more? A. we have over 30 groups (in the Albuquerque Area who aren't reprsented at Intergroup) so I can take 10 to each. All in Favor. None opposed. Motion Passes. Discussion about new employee and finances: What is the real issue, has there been a short fall? We had a short fall last year and that's it. The steering committee needs to have a hold on the finances. Let's look at money and services. Can the office run on Michael working 40 hours a week? What services are we providing to the groups? We cannot raise revenues and go to groups saying we need more money in order to run.Michael- Benefits for having an alternate coordinator is to insure continuity and stability for the services provided. I am responsible for the way the office is run (phone, desk, bills). This central office started when the groups in ABQ got together and said they would support the running of an office. We can look at statistics that show other offices- but some things are an anomaly. If something happened to me, someone needs to be ably to step in and take care of things, not to make sure I am not overworked. Many things I do, I do out of choice. We have operated in a deficit, so we reduced the prudent reserve. There has been a focus on money, while this is important, it is not the primary purpose which is crazy making. We can' focus our energy on the office and money- it takes the focus off our primary purpose which is fellowship and the alcoholic. I believe we have wondered off in the weeds with our energies- An alternate coordinator helps maintain a sound reasonable running of the office. Steve: Legally any business which operates 7 days a week needs management to manage- Michael cannot be there 7 days a week. Yes we had problems with money last year, but we have had many years where we didn't. Al- It's not shameful to ask groups to support us. We have always done that. We are working for the groups and need support in order to do that. Also I want to point out that the view points you are hearing are just a small minority. Deb- we have to reach out to still suffering alcoholics- half measures avail us nothing.Don- This is about how to run an office. The steering committee wanted to put together a budget and see how much money comes in. We want a central office- but what services do we want to pay for? That is the question. We are not trying to instill fear, we just want to get a grip on how things are run, and what services do we want to pay for? George: 2 out of last 3, and 3 out of last 11 years we have operated in red. Point about continuity Michael brings up is very important. We don't have a disaster plan? I take self supporting through our own contributions very seriously. Christy: I know previous treasurer left things in limbo- new treasurer had a hard time in beginning. I'm hearing we want to change how the office is run. But I think we need to take this slow in order to look at it. I hear some dissension, but we don't need that. I think we do need the alt. coordinator to help out.Ashley: I gave groups info about looking at salaries. That was just info- we just want to look at how things are run. Ally- seems there are a lot of opinions-I don't know what the facts are or if this should even be discussed. There is disunity and I want everyone to get along. The question of importance is how best we serve the groups? Peggy: This was 1st brought up because I want a little more time in order to hire a new person. I'm not asking to change things, I just want more time. I'm asking this intergroup meeting to make a decision for more time. I have already offered my time, but Michael has so many people helping him out already, so it doesn't feel urgent. Let's take it slow and maybe a month at a time to discuss these issues. I don't want to fight about this either, but adults can have issue and disagreements. Steve: Michael has been doing a great job and we have placed our trust in him, if he thinks hiring a new person is best than we should find a way to afford it. Kristen- I want to understand that you want a motion to have the applications taken later than august to give you more time? Kris- I add that if we extend it than we make sure we have the business covered (ie. volunteers to be at office). I think it's really prudent to take some time, but we only have one person to run.Kristen- I still think we should still take applications during this time. Peggy: I think the applicants need to know that we are considering the position and looking at weather we can afford it. Cindy: I think it's always prudent to have a backup- it's not safe to just have one person who does everything. It is difficult to talk about money and budgets, especially in AA. But I think we do need to look at this- maybe have a set time frame rather than do it month to month. I think it's ok to run in the red and ask groups for help when needed. It's discomforting that the steering committee have such a discord and it was brought to us in this manner. Alli- I think the time frame has been established. We are accepting applications till end of July- we have time to look at position till then. If a motion is made it's already within the bounds and it has been passed by steering committee to move forward.


